#### 7. Resolution

The Combined Fire Authority (CFA) approved the following resolution without discussion.

# 8. Options for the Future Appointment of the Chief Fire and Rescue Officer/Chief Executive Post

The Chief Fire and Rescue Officer (CFO) presented this report which sets out options for resourcing the post of Chief Fire and Rescue Officer/Chief Executive, following the retirement of the incumbent.

The CFA discussed the report in depth and remained committed to ensuring the way forward must be in the best interests of the organisation going forward, noting the need to consider all options and looking for efficiencies where feasible.

The Deputy Chief Fire and Rescue Officer and the Director of Community Services left the meeting during the discussion of this item and before a vote

was taken.

Mr M Charlesworth CC moved Option B as presented in the report for the redistribution of responsibilities within the Senior Management; this was seconded by Mr M Wyatt CC.

A vote was taken with 2 in Favour, 11 Against and 2 Abstentions.

The motion fell.

Ms B Newton moved Option C as presented in the report to recruit to the post. This was seconded by Mrs P Posnett CC.

A vote was taken with 11 in Favour, 2 Against and 2 Abstentions.

The motion was carried.

The Chair moved that the salary be set at £139,220 as detailed in the Appendix to the report at paragraph 3.3 this was seconded by Mrs J Fox CC.

A vote was taken with 11 in Favour, 1 Against and 2 Abstentions.

A further discussion with regards to the interim arrangements will take place at the CFA meeting in February 2015.

- b) Authorised the Solicitor and Monitoring Officer to make the necessary changes to the Pay Policy Statement to reflect the arrangements agreed, revised salary and the recent changes to the level of CFO and Directors' pay following the 2014 national pay award.
