#### 13. Exempt Item - Organisational Change Project

The DCFO informed the Committee of the progress to date on the proposed process to be undertaken to ensure a balanced budget in future years. A wide ranging discussion took place including the following points:

- Without the onset of the reduced Government Grant, would you have engaged in this process anyway?
- Documents need to be totally accessible and easy to understand by the public.
- Communication of the consultation will be facilitated by the use of an external public survey organisation, Opinion Research Services (ORS).
- Keep a sound knowledge of where we are, where we want to be and how we aim to get there.
- Members confirmed where possible they would be happy to assist with handing out documents.
- Citizen Panels are still held at Wigston and Hinckley and Bosworth Councils.
- Take advantage of community meetings

- Would it be a good option to list questions separately as people mainly go to the areas they are personally interested in?
- Lobbying of MPs should take place to be discussed at next CFA meeting
- Whether there should be a Council Tax Referendum would also be discussed at next CFA meeting
- The CFA requested it be noted that they wish to have a report presented to a future meeting of the Overview and Scrutiny Committee in respect of 'Co-operation with other Emergency Services'.
- ORS to run a presentation on 5<sup>th</sup> November at Policy Committee with all members to be invited.
