It also sought a decision on the level of Council Tax for 2015/16.

A detailed PowerPoint presentation was delivered to enhance the information. The 2015/16 Council Tax options to be presented to the CFA were as follows:

- 0% + Freeze Grant
- 1.5% (2014/15 Level)
- 1.99% (Maximum Referendum Limit)
- £5 (As per the Integrated Risk Management Plan [IRMP] Consultation)
- £10 (As per IRMP consultation)

The Committee noted the options for the 2015/16 Council Tax to be presented to the CFA in February.
