1. Purpose

- 1.1 Section 21 of the Fire and Rescue Services Act 2004 requires the Secretary of state to prepare a Fire and Rescue National Framework which sets priorities and objectives for Fire and Rescue Authorities (FRAs). The draft consultation was sent to FRA on 27 December 2017 with a close of 14 February 2018.
- 1.2 This report asks the Combined Fire Authority (CFA) to approve the response to the consultation.

3. Executive Summary

- 3.1. A draft National Framework for England was sent to FRA from the Home Office for consultation on 27 December 2017 closing 14 February 2018. Under Section 21 of the Fire and Rescue Services Act 2004, it requires the Secretary of State to prepare a Fire and Rescue National Framework which sets priorities and objectives for Fire and Rescue Authorities (FRAs).
- 3.2. Appendix 1 contains the response to the draft framework.

4. Report Detail

- 4.1. Section 21 of the Fire and Rescue Services Act 2004 requires the Secretary of state to prepare a Fire and Rescue National Framework which sets priorities and objectives for Fire and Rescue Authorities (FRAs). The draft consultation was sent to FRA on 27 December 2017 with a close of 14 February 2018.
- 4.2. The National Fire Chiefs Council (NFCC) will be responding to the draft Framework, this report considers the submission from the NFCC and does not conflict with that submission.
- 4.3. The current National Framework document was published in 2012.

- 4.4. The Appendix 1 is page 29 of the draft national Framework for England, the consultation return is structured to align with the sections of the main document, additional comments can be submitted at the end of the document.
- 4.5. The draft National Framework is unlikely to change significantly following the consultation. Any changes that may impact on our plans will be reported to the CFA.
